

 - CMS released a final local coverage determination (LCD) for Sacroiliac Joint Injections and Procedures. The LCD, which goes into effect in March, was developed and adopted by five out of seven MACs. <u>Download local coverage</u> <u>policies</u>.
 - Breast imagers in NY and IL are being audited by Medicare and experiencing claim denials related to breast US for screening; Medicare does not pay for a breast ultrasound when performed as a screening study, only for diagnostic purposes. Breast Imaging, Economic Policy, and Government Relations experts convened virtually to discuss this coverage topic. Dr. Dana H. Smetherman served as a guest columnist for the <u>ACR Bulletin</u> and <u>Voice of Radiology</u> blog to communicate this important policy to ACR members.

- Staff informed members via Advocacy in Action that beginning July 1, 2023,
 Facet Joint Interventions has been added to the Hospital Outpatient Department
 Prior Authorization program. This update is relevant to interventional radiologists
 as it will require prior authorization as a condition of payment for facet joint
